# **Inaugural Session**

Keynote Speaker: Dr. Ganesh A. Hegde, Advisor, NAAC, Bangalore

**Dr. Ganesh Anant Hegde, Adviser, NAAC Bangalore** is an expert academician in the assessment and accreditation arena in the country today. He has been at the helm of affairs at the country's top assessment body, the National Assessment and Accreditation Council, for more than two decades now in several capacities. He is keenly involved in the framing of assessment framework of NAAC for the last two decades and has to his credit the expertise of assessing and accrediting more than 1400 Institutions of Higher Learning across the Country. In addition to this, he is involved in designing and conceptualizing assessment manuals in specialized areas of health, teacher education, guidelines, publications etc. He holds a Doctorate degree in Mass Communication and Journalism from the University of Mysore.

Dr. Hegde has organized several workshops for Principals and Faculty members for undergoing the process of Accreditation. He has conducted several Assessors'Training Programmes at NAAC for Vice Chancellors, Professors and Principals all over the country for training prospective NAAC Peer Team Experts. In addition, he has co-ordinated the review of 66 Academic Staff Colleges of UGC and submitted a report. He has been instrumental in bringing out the Internal Quality Assurance Guidelines and other Publications.

Dr. Hegde has contributed his professional prowess in the International arena as well. He has participated and contributed in National and Inter-National Seminars on Higher Education, Assessment and Accreditation, Internal Quality Assurance System, Quality in Teacher Education, Best Practices and APQN online discussion and so on. ## **Key Note Address**

During his key note address, Dr Hegde emphasized that online process for filing the accreditation process for registration is must for all the institutions including the institutions that already have NAAC score and are entering the process of Re-accreditation. Documents must be carefully attached while online filing of application. Teacher Profile and Quality, Student Satisfaction Survey, Innovation Ecosystem, Alumni Engagement, Institutional Values and Social Responsibilities, Institutional Distinctiveness aresome of the important criteria stipulated by NAAC that should be carefully analyzed and evaluated. NAAC manuals and all related documents must be carefully read before filing for the accreditation process. 3C model is very important for quality enhancement of an HEI- Competition, Cooperation and Collaboration- as working on this model one can come up with new ideas and new horizons can be achieved.

## **Technical Session-I &II**

#### Dr. Shyam Singh Inda, Assistant Adviser, NAAC, Bangalore

Dr. Shyam Singh Inda is currently working as Assistant Advisor, NAAC. He has served as a faculty in Human Resource Management in two leading Universities and was also associated with Nationalized Bank and Central Government. He holds Ph.D, MHRM, PGDHRM, PGSDOM, B.A. inRussian with Honors in Economics. He also qualified the UGC – NET exam in HRM.

With more than a decade of experience, a background of Defense Services and 30 acclaimed & published research articles in peer reviewed International Journals and 2 Books to his credit, he excelsinthe field of academics, corporate and development sectors. He is highly experienced in research & data analytics too.

#### Session I: DVV and Peer Team Visit Details

During his presentation, Dr. Inda emphasized that Data Validation and Verification (DVV) is the most important part of Revised Accreditation Framework RAF). Data validation and verification is validated by the NAAC service provider. Extended Profile of the Institute and QuantityIndicator metrics are two parameters that are verified through this process. He explained that the RAF includes evaluation of an HEI on two basis- the qualitative and the quantitative metrics. The Quantitative metrics add up to 65% of the weightage and the rest 35% weightage focuses on the Qualitative metrics. The data submitted on quantitative metrics by the HEI will be subjected to validation exercise with the help of data validation and verification partners of NAAC. The responses to qualitative metrics will be reviewed by the Peer Team on site only after the institution clears the pre-qualifier stage. The DVV partners will validate the entire data uploaded by the HEI in a period not exceeding 30 days. Dr.Inda explained the entire process with great clarity and lucidity.

#### **Session II: Student Support & Progression (SSS)**

In the second technical session, Dr. Shyam Singh Inda focused on the online Student Satisfaction Survey (SSS) as an essential component of the Accreditation process. Under Criterion II of NAAC Manuals, Key Indicator 2.7 and QnM Metric 2.7.1- the HEIs have to submit the students' list across all programs and disciplines enrolled during the current session. Concurrently, with the DVV the Student Satisfaction Survey will be conducted online by NAAC. However, this is not a part of the prequalifier. SSS link is valid only for 10 days for activation and completion. Students are questioned in the SSS on various parameters including- Teaching learning process, Subject-specific skills of teachers, Teaching methodology, Teacher-Student relationship, etc. HEIs have to be careful while uploading the data of its students which has to be uploaded in the particular format as prescribed by NAAC. The SSS comprising of 20 objective and one subjective questions is available on the NAAC website. The SSS will be emailed to the students following which their responses will be evaluated. SSS questionnaire is in English. NAAC website will have both English and Hindi version available. If needed HEIs can make local language translation available for information of students before they take the survey. Dr. Inda apprised the participants in detail about the SSS and other aspects of Student Support and Progression.
