### Minutes of the Meeting


The meeting of the Grievance Redressal Committee was held on 12 November 2021 at 01.30 pm in Principal's Office.

1. Monitoring of grievances posted by students.


#### Proceedings:


1. Confirmation of the minutes of the Grievance Redressal Meeting held during previous session.
