

Sanatan Dharma College envisioned by the *great Sanatanis and Social Reformers* Mahamana Pandit Madan Mohan Malviya Ji and Shri Deen Dayal Upadhyaya Ji was established in 1916 at Lahore. The partition of India was a huge set back to the institution. However, it goes to the credit of Tyagmurthi Goswami Ganesh Duttji, who rehabilitated and re-established the college in Ambala Cantt in 1948. The Ministry of Defence provided 10.32 acres of land and with the help of various philanthropists, the construction for the college building was in the pipeline.

The college is recognized under sections 2(f) and 12(b) of UGC Act 1956. The management, staff, students and the civil society have worked in tandem to establish it as a multi-faculty, premier, **co-educational institute of higher learning** which has acquired the dimensions of a mini-University. The college offers **16** undergraduate and **07** postgraduate courses. At present there are **99** teachers and around 3000 students.

After 107 years of its commitment to excellence in Higher Education, the institute extended its mission of integration of ICT in teaching learning and made a conscious effort to train campus community and teaching fraternity nation-wide. E-content development cell of the college has trained more than 5000 educators from different schools and colleges. As a result a huge collection of e-resources have been generated by the faculty. The quality conscious management readily became a part of the accreditation regimen. 1st Cycle of Accreditation was carried out in 2003, awarded Grade B++; **followed by** 2nd Cycle of Accreditation in 2011 with the award of Grade A; 3rd Cycle of Accreditation in 2017 resulted in Grade A+ with CGPA 3.51. However, it was in the latest Cycle-IV in 2023 that College etched its name in the annals of educational history, securing the highest grade in Haryana and standing second nationwide. With an unparalleled Grade A++ and an exceptional CGPA of 3.72, the college emerged as a radiant beacon of academic brilliance, illuminating the path for others to follow. Glossary

Major and Minor Subject: Major subject is a subject of choice in a discipline which equips student with knowledge, understanding and skills majorly in the chosen field of learning contributing to the core of the programme.

Minor subject the is a student to gain a broader understanding in addition to the Major subject.

The courses in a Major discipline will be Core Courses(CC), Discipline Specific Elective(DSE) courses, Discipline Skill Enhancement Course(DSEC), Practicum (PC), Project/Dissertation, while Minor courses will include CC as well as Vocational Courses(VOC).

Core Course(CC): A compulsory course of a subject aimed to cover the basics of Major/Minor subject.

Discipline Specific Elective(DSE) Course: A discipline specific elective course is a course aimed to impart options for varied knowledge and s kills in the specialized fields of a Discipline/subject.

Discipline Skill Enhancement Course (DSEC): A discipline skill enhancement course is a course aimed to provide knowledge, skills, training and competencies in a discipline/subject.

Vocational Courses(VOC):A vocational course is focused on practicalwork, preparing students for a particular skilled profession. Such courses develop capacities for sustenance, work, and economic participation and develop values and sensibilities toward physical work and dignity of labour.

Other Courses

Multidisciplinary Courses(MDC): These courses are based on introductory knowledge in a subject. A student will study MDC in a subject other than the discipline of Major and Minor subjects to gain knowledge across the disciplines.

Ability Enhancement Courses (AEC): These courses aim at enabling the students to achieve competency in the English language or Modern Indian Languages(MIL) with special emphasis on language and communication skills.

Skill Enhancement Courses(SEC): These courses aim at imparting practical skills, hands-on training, soft skills, etc. to enhance the employability of students.

Value-Added Courses (VAC): These courses aim at enabling the students to acquire and demonstrate the acquisition of knowledge and understanding of human values, Indian Knowledge System(IKS), contemporary India, environmental science and education, digital and technical solutions, health and wellness, yoga education, sports and fitness, etc.
